1. THAT there shall be four (4) wards with seven (7) elected school trustees in Pine Creek School Division effective as of October 22, 2014 trustee elections as follows:

Ward 1	Langruth/Plumas	1	Trustee
Ward 2	Gladstone	2	Trustees
Ward 3	Austin	2	Trustees
Ward 4	MacGregor	2	Trustees

2. That the four (4) new wards (as per map Exhibit CCAD-E) shall be as follows:

The current Ward Two (Plumas) ward to be deleted and amalgamated in to the new Ward One (Langruth/Plumas) and the new Ward Two (Gladstone) wards as outlined below.

The former Ward One (Langruth) ward shall be renamed Langruth/Plumas and the boundaries adjusted to include the following:

All or parts of the following sections in Pine Creek School Division:

Sections 1, 2, 3, 4 of Township 16 Range 13; Sections 9, 10, 11, 12 of Township 16 Range 13; Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25 of Township 16 Range 12; Sections 2, 3, 4, 5, 6 of Township 16 Range 11; Sections 7, 10, 11 of Township 16 Range 11; Sections 14, 15, 16, 17, 18 of Township 16 Range 11; Sections 19, 20, 21, 22, 23 of Township 16 Range 11; Sections 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36 of Township 15 Range 12; Sections 14, 15, 16, 17, 18, 19, 20, 21, 22, 23 of Township 15 Range 11; Sections 26, 27, 28, 29, 30, 31, 32, 33, 34, 35 of Township 15 Range 11.

The current Ward Three (Gladstone), to be amended to Ward Two, boundaries shall be adjusted to include all Sections in Township 14 Range 12; all Sections in Township 13 Range 12; Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 22, 23, 24, 25, 26, E ½ of Section 27, E ½ of Section 34, S ¼ of Section 34, 35, 36 of Township 14 Range 13; Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 22, 23, 24, 25, 26, E ½ of Section 27, 35, 36 of Township 13 Range 13; Sections 1, 12 of Township 15 Range 13; Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 of Township 15 Range 12.

The current Ward Four (Austin) to be amended to Ward Three. Ward boundaries are unchanged, and include the following:

All lands included in the Unincorporated Village of Austin.

Sections 25 and 36, Township 10 Range 13

Section 13 Township 11 Range 13

N ½ section 1, all sections 12, 13, 22 to 27 and 33 to 36 Township 12 Range 13

All sections in Township 11 Range 11

All sections in Township 12 Range 11

All sections in Township 12 Range 12

All sections in Township 11 Range 12

All sections in Township 10 Range 11

All sections in Township 10 Range 12 except all section 6, W ½ section 7, and all section 18

Sections 13 to 17, 20 to 29, and 32 to 36, Township 9 Range 12

Sections 19 to 36, Township 9 Range 11

Section 7 north and east of river, section 8 west of river and section 17 north of river, all sections 18 to 20 and 29 to 32, Township 9 Range 10

The current Ward Five (MacGregor) to be amended to Ward Four. Ward boundaries are unchanged, and include the following:

All lands included in the Town of MacGregor

All sections in Township 12 Range 9 except Section 1, SE ¼ section 2, sections 12 and 13, E ½ section 24

All sections in Township 12 Range 10

All sections in Township 11 Range 10

All sections in Township 10 Range 10

All sections in Township 11 Range 9 except NE ¼ section 12, SE ¼ section 13, E ½ and NW ¼ section 24, all section 25, E ½ section 26, E ½ section 35 and all section 36

All sections in Township 10 Range 9

Sections 2 and 3 south of river, SW ¼ section 4, all sections 6, 7, 18, 19 and 30, S ½ section 31 Township 10 Range 8

NNW section 14, NE section 13, E ½ sections 22, 27, 34, All sections 23, 24, 25, 26, 35, 36 Township 9 Range 9

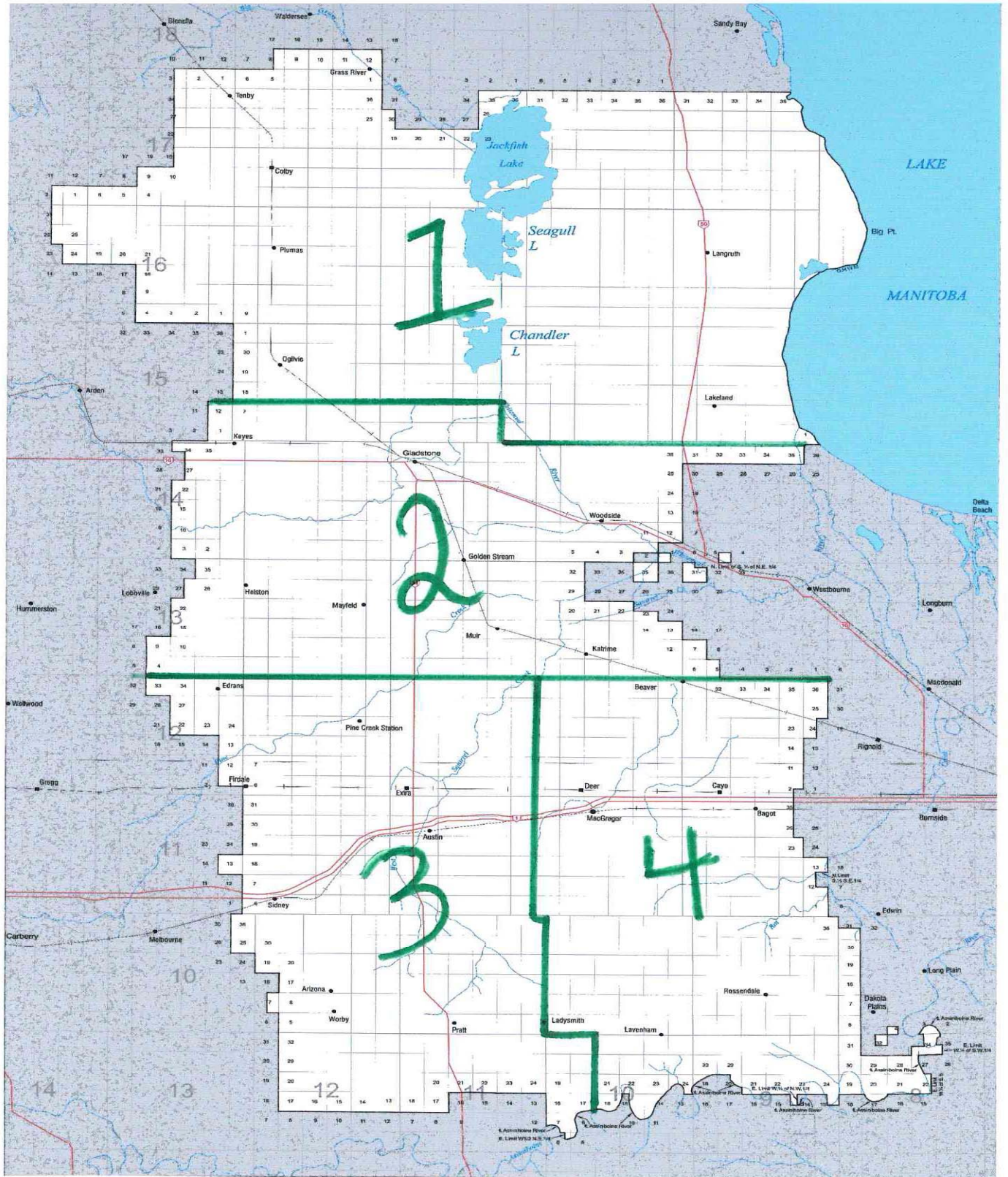
